


## FACTS™ – Objective Determination of Fatigue Incidents

FACTS is a web-based system that will let you know the probability of whether a person was or was not impaired by fatigue at the time of an accident or incident. FACTS is:

- <u>Objective</u> Creates a standard for investigating all incidents, accidents and near misses.
- <u>Scientifically validated</u> FACTS probability judgments correlate 86% with the judgments of expert human panels.
- <u>Easy to use</u> No training required. Features a simple drop-down menu for collecting the incident data as part of the normal accident reporting process
- <u>Fatigue Risk Management System Tool</u> In a data-driven FRMS, FACTS allows an organization to assess, benchmark and measure the impact of their FRMS initiatives in terms of reduced costs, risks and liabilities.

#### FACTS™ Validation



FACTS was validated with two data sets:

- 1. Data from exhaustive NTSB investigations of 102 truck accidents to determine the role of fatigue.
- 2. Investigation data from 44 diverse industry and transportation accidents analyzed by Circadian experts during litigation cases.

**Results:** Fatigue probability determined by FACTS showed high correlation (86%) with expert assessments.


### Why Do You Need FACTS™


Until now companies have not had a systematic nor reliable tool for investigating fatigue.

#### How Does FACTS™ Work?




#### STEP #1

#### STEP #2

The probability of fatigue impairment is instantly calculated by the FACTS website. The more answers the user provides, and the more accurate these answers are, the higher the degree of reliability of the FACTS score.



#### **STEP #3**

Approved corporate administrators of your FACTS system can access a Graphical Reporting Interface, featuring real-time visualization of data.

The user can obtain statistics and identify trends by filtering, displaying and downloading incidents based on factors, such as: Time of Day, Day of Shift, Type of Activity, etc.
